3.0 RESIDENT REQUESTS -

1. Stephanie's neighbor the Cava's would like to know if we can change light fixtures. Rodger will follow up.

2. Jack Rugar would like to have the minutes of the meeting posted on the website sooner. It was decided that the minutes would be posted 15 days before the meetings when possible. Asked to have insurance policy scanned and posted on Website along with the cost of our umbrella policy with Travelers Insurance. He asked that we be sure to add insurance to the Agenda in Jan & Feb 2009 for plenty of time for review.

3. Request by Alice Messinger #58 for new metal French doors be installed. Scala will contact and explain that owners are responsible for the price difference and must file an architectural approval.

4. Bomberger brought up the issue about Pacific Grove diverting the drain water from our "lake". Ken Morley says this is unlikely but will follow up on any new developments.

5. Axt pointed out that #40 has a leak in entryway of her unit. She has asked the plumber to check it out. It may be a problem with the irrigation. He will follow up.

5.0 REPORTS

- 1. **FINANCIAL REPORTS** Treasurer Axt reported that a new CD was set up at 3.350% and comes due 1/30/09. We now have \$507,000 in reserves.
- 2. **NEW RESIDENT INFORMATION REPORT**: Lauritsen reports new tenants in unit #14 and #76.
- 3. **MAINTENANCE REPORT** Axt reports of the leak in #40 may be irrigation problem will keep informed.
- 4. LAKE REPORT: Bomberger asks about cleaning the lake with long handle rakes. Rakes need to be replaced, Axt will handle. Axt will get some workers to clean the new plants in Lake.
- 5. WILDLIFE CONTROL REPORT: Scala reports that there were no raccoons but will call a pest control company to get rid of gophers.
