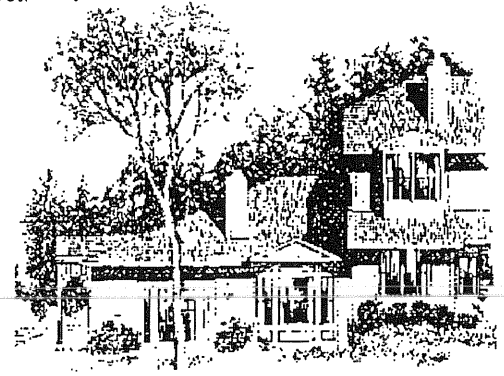

Fences to Retard Trespassing

The Board voted to install fences going up the hill to the right of the gate (as you face the gate) and to the left of the first garage which presently provides open access to the Glen.

The number of trespassers has increased during the last few months. One fell into the lake. Since we are liable for any harm coming to these persons, we feel the expense to discourage entry is warranted. We are in the process of acquiring bids for this work. It will be done in the most efficient and economical way possible.

Lake Pumps Repaired

The lake pumps have been repaired. In order to preserve them from damage from condensation and rain, a new cover that will prevent water seepage will be constructed.

Postal Department To Install New Mailboxes

The Postal Department is in the process of acquiring and installing new mailboxes. This should be done within the next two or three weeks. A few days before installation, the Post Office will send a letter with a new key to each address.

CalTrans Approached to Keep Catch Basins Clean

Because Glen Lake is a holding basin and receives run off from the surrounding hills, it is important that the catch basins above us be cleaned often of garbage, pine needles, etc. The Superintendent of the Highway has been contacted by phone and by letter and promises to do what he can.

Residents who violate the Guest Parking spots will receive warnings in the form of a notice placed on the car. If that is ignored, a letter will be sent.
